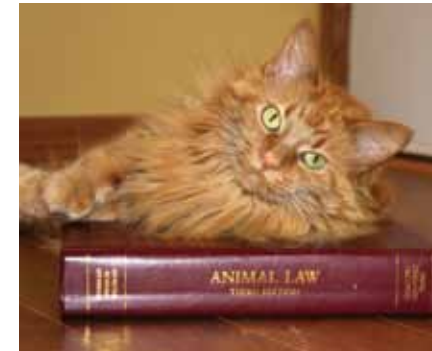
## Exceptional Animal Law Opportunities

## Who We Are

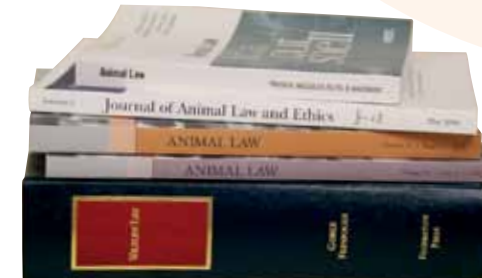
