 - B. Vote on Samantha?
 - C. Lots of discussion about whether it is appropriate for us to replace Joseph today, or whether we should open it up to the student body as a whole.
 - D. Rob Bart moves to table the nomination of Samantha until we're clear on this problem.
 - 1. The motion carries and we'll table the vote for now.
 - E. The Rules committee and the Elections committee will consider the issue of appointments.

III. Budget! Eek!

- A. Overview by Maryam on internal budget committee meeting
 - 1. The committee met and came up with guidelines for allocations.
 - 2. The guidelines were applied very consistently throughout all the budget proposals.
 - 3. Question about the process of requesting funds
 - a) Only SBA approved clubs are allowed.
 - b) There are no guidelines in the bylaws about what they can request money for.
 - c) There's a consensus among the budget committee that this is not the best way to do it. Perhaps to the rules committee?
 - 4. Events that weren't accessible to the student body as a whole were not prioritized.
 - 5. We have a new budget for a cosponsorship fund (\$1000) for clubs that cosponsor events, this was how Michael used his discretionary fund.
- B. We have an audit in January of all the clubs to see what they're spending.
- C. Motion to approve the budget
 - 1. Budget is approved!!

- A. Internal committees- no reports
- B. External committees
 - 1. Board of Visitors
 - a) Talked mostly about the budget.
 - (1) They're trying to lower incoming class numbers.
 - b) Talked about how to move our ranking higher.
 - c) Discussed job placement.
 - 2. Budget Committee
 - a) \$1.6 million hole in the budget even after cutting the incoming class size by 25 students.
 - b) 3% tuition hike is discussed, less than usual but still significant.
 - 3. Alumni Board
 - a) The Alumni really care about us!
 - b) Lots of work on job placement stuff.
 - c) New recent grad council has been formed to support new graduates.
 - 4. Faculty Committee
 - a) Hiring 3 adjunct professors as writing assistants to help students outside of class.
 - b) Committed to working transportation alternatives.
 - c) Thinking creatively about the budget.
 - d) Dean Klonoff instituted a bar prep course to accompany Barbri a few years ago and it has been a success.

VI. Other Business

- A. Customer Service Petition
 - 1. Comments
 - a) Perhaps we should list ALL the customer service depts.
 - b) It's not focused enough to be effective.
 - (1) Lots of folks agreed with this.
 - (2) Some suggestion that it was kept vague for a reason.
 - c) The usage of the language "customer service" may be perceived as demeaning.

- (1) This might be a term the school actually uses.
- d) Concern is very valid, but this will just "piss off" the people we want to change. This might not be within the SBA's role.
- e) Perhaps we could do some more information gathering before we send something like that out.

2. Questions

- a) Who will it be given to? The Administration, specifically Deans Klonoff and Spence. Will be left to Michael's discretion.
- 3. Motion to send an official delegation to talk to Dean Klonoff
 - a) Passed.

B. Dogs in common areas

 - b) Hallways are vacuumed often.
- 3. Faculty and animal law try their hardest to be sensitive to these concerns.

- 2. Two options
 - a) Each SBA member has a week that they clean out the kitchen.
 - b) Or each student group cleans out the kitchen one week.
- 3. Comments/ Questions
 - a) What about the cleaning service? Unsure if we can ask them to do this?
 - b) Could be a good way for SBA to boost their image.
- 4. Motion to do a temporary solution while we figure out if the cleaning crew can do it.
 - a) Approved.

D. Class size recommendation

- 1. CJ has a "Law School Restructuring Endorsement"
