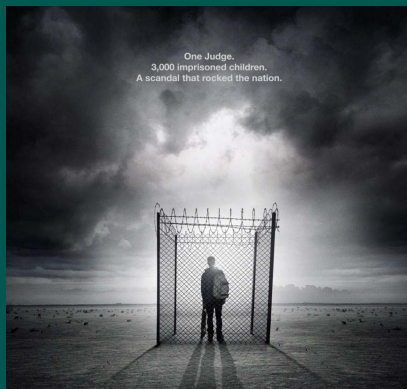

Pushing the Envelope Without Ripping it Open: The Ethics of Counseling Clients in Gray Areas

Justice Holmes famously stated that the meaning of a line in the law is that one can walk right up to it with impunity. Often, however, there is no clear line, and both lawyers and clients must deal with varying, and sometimes shifting, shades of gray. The Oregon Rules of Professional Conduct allow lawyers to discuss the proposed legal consequences of potential conduct with clients but prohibit knowingly counseling or assisting a client in illegal conduct. Moreover, the Oregon version of this rule appears to be purposefully more strict than the ABA version.

This session will address how lawyers facing such “cutting edge” issues can simultaneously identify and address these ethical risks while serving their clients’ needs.
