Widely considered one of the top public-utility lawyers in the Northwest, he chaired the Oregon State Bar's Public Utility Law Section and was listed in The Best Lawyers in America for more than a decade.

Jim was a mentor to many, both within and outside of the firm, and always sought to bring out the best in people. In 1986, his family and friends created a scholarship in his memory that would go towards tuition for a Lewis & Clark law student (or students). The scholarship is awarded each year to a student (or students) with one more year of law school left who best exemplifies Steven's adventurous spirit, love of the outdoors, and passion for environmental protection. In short, the scholarship recognizes students with that "special something" that reminds the environmental faculty most closely of Steven.

## **Purpose of the Scholarship**

- To recognize individuals with a demonstrated commitment to environmental protection and the prudent management of natural resources; and
- To facilitate continued participation in activities involving environmental and natural resources issues, on and off-campus.

# <u>Criteria</u>

- Applicant must be a current second year day student or third year evening student with one more year left of law school.
- The recipient must demonstrate a commitment to environmental protection and the prudent management of natural resources, as evidenced by participation in relevant on <u>and</u> off-campus activities.

The purpose of the scholarship is to recognize individuals who have demonstrated a commitment to the betterment of the legal profession and the law school community, and who give of themselves to take up for the underdog, whoever or whatever that might be.

### **Criteria**

- Applicants must be enrolled in law school during the 2010-2011 academic year.
- The scholarship will not be awarded twice to the same person.
- The scholarship recipient must be in demonstrable need of financial assistance and must be in good academic standing. Grades are not a primary criterion, but may be taken into consideration by the committee.
- The recipient must show a commitment to the law school as a place that can provide quality legal education in a collegial and supportive environment. This may be evidenced by on-campus activities showing an engagement and involvement in the law school community.
- The recipient must show a commitment to the legal profession. This may be shown by engagement and involvement in activities working toward the betterment of the legal profession and by personal example showing that the legal profession is one attracting talented, ethical individuals prepared to use their skills in a way that meets the highest standards of the profession. Applicants may wish to cite activities on-campus or off-campus.
- The recipient must show a commitment to those not always in a position to speak for themselves. This may be evidenced by activities on-campus or off-campus and may include activities prior to attending law school.

### **Specific Application**

Applicants are required to submit a statement that addresses how the applicant meets the criteria stated above.

### Background

Andrea Swanner Redding, Class of 1986, died on April 5, 1996. At the time of her death she was the Assistant Dean for Career Services at the law school. Her professional affiliations included active membership and involvement in Oregon Women Lawyers, the National Association for Law Placement, the Oregon State Bar Association, and the Multnomah Bar Association. One of her colleagues at the law school said, "Her professionalism set the standard... Her membership in organizations was not merely a name on the dotted line, it was an

active participation designed to enhance the lives of us all... students, graduates, all lawyers, and the clients we serve."

During her tenure as director of career services and assistant dean she transformed the career services office. She added dozens of new programs and services to those that had already been offered. She involved more alumni than ever before, both locally and across the nation, in a variety of activities. Locally she implemented a mock interview program and a series of receptions at law offices for first year law students. Nationally, she traveled all over the country calling on people she didn't know and asking for a little of their time to let them know what terrific students the law school was graduating and explaining why these employers should hire them. On one trip she had 25 appointments in four days.

She was described by many as "tireless." She worked for students in the aggregate when she made trips to visit potential employers. She worked for students individually, counseling literally hundreds of people each year about which offer to accept, how to improve a cover letter, or how to decide which area of law might be best for a particular person. Every attorney she met was a potential employer and every student looking for a job was her client. She saw her job as being the career services director to all the students, not just a chosen few.

At a service celebrating her life, dozens of attorneys, current students and alumni, and colleagues from the law school shared their memories of Andrea. The words that were repeated again and again were "tireless... grace... style... led by example." She was colorful, both figuratively and literally, she was bright and energetic and fun. To the tasks put before her she brought wit and imagination, ambition and integrity, tremendous energy, and immeasurable devotion. Her contribution to the law school was significant and cannot be adequately measured (*Adapted from "The Advocate" Spring 1997*).

- Applicant must be in the 3<sup>rd</sup> year of the evening program.
- Applicant will be enrolled in law school during the 2010-2011academic year.
- Student must have attended the evening program for the full extent of his/her law career.
- Student must show need of financial assistance.
- Student will exhibit superior integrity and high ethical standards.
- Student must show excellent scholarship as a law student.
- Student must show a caring attitude toward others.

## Specific Statement

Applicants are required to submit a statement addressing the following:

- A description of long-range professional interests and goals
- One written recommendation and the names, phone number and email addresses of two references who can comment on your suitability for this scholarship based on the scholarship criteria.

*Note:* references must include at least one Law School professor and one fellow student.
