# Course Description:

Practical survey of lobbying and litigation on behalf of animals at the local, state, and national level. The course will address the historical status of animals in the law; legislative drafting and lobbying; application and enforcement of federal statutes such as the Animal Welfare Act, the Humane Slaughter Act, the Endangered Species Act, the Marine Mammal Protection Act, the Migratory Bird Treaty Act, Wild Horses and Burros Act, and the Animal Damage Control Act; international conventions concerning trade in animals and animal products, free trade, and comparative animal protection laws; state laws and citizen initiatives concerning anticruelty, hunting, trapping, animal fighting, performing animals, and farm animals; veterinary malpractice and consumer protection actions; free speech, religious expression, and other Constitutional limitations on animals protection statutes; the movement to obtain legal recognition of the rights of animals; and innovative uses of existing laws to expand legal protection of animals.

## Evaluation:

Student grading will be based on completion of a final examination (66%) and class participation (34%). Class attendance and participation are an important component of a successful seminar and students will be expected to be ready to discuss the assigned reading for each session.

The syllabus sets forth the basic reading assignments for class sessions, which may be supplemented each week with additional materials. Exact dates and assignments may change as the course progresses, and there will likely be occasions where the subject from one class will carry over to the next.
