#### III. Customer Service Survey Results

- A. Survey: School Administration conducted a Customer Service Survey after being approached by the SBA
- B. Administration's Response:
  - (i) Positive feedback from Dean Spence, citing that the results were useful
  - (ii) Plans on conducting an iteration of this survey annually
  - (iii) Suggest addition of the Copy Center and Bon Appetit to future surveys

#### C. Results of Survey:

- (i) Approximately 240 respondents to the Survey
- (ii) Career Services Office and Business Services Office, though mostly positive, had the largest number of negative feedback
- (iii) Business Services had the lowest positive score, with 60% of students rating them as "Excellent" or "Good"

- (iv) Many of the services on the survey didn't have respondents due to less recognition of those services
- (v) Administration is actively discussing the results of the survey.
