
Jonah Sandford:

Working with the NEDC Water Group has been invaluable for me as one of the few opportunities over the 1L year to gain practical legal experience in the environmental field. This year I had the privilege of commenting on several industrial stormwater discharge permit applications submitted to Oregon's Department of Environmental Quality, as well as the Columbia River Crossing project's application for a dredge and fill permit from the U.S. Army Corps of Engineers.

These opportunities allowed me to work for the first time with the Clean Water Act and to engage in a meaningful way with environmental issues impacting the Pacific Northwest. Beyond this practical experience, it has been really inspiring to spend time with the NEDC staff and project group leaders. Everyone in the organization is always willing to offer guidance and support. Even during the 1L year I was always made to feel like a valuable member of the team. All year long my experiences with NEDC have served as an excellent reminder of why I came to law school in the first place, and I think it has given me a great start toward a career in environmental law.


