

**Spring 2019** Unscheduled Exams: Exams are held for two weeks at the end of the semester. The full exam period begins Friday, April 19 and ends Tuesday, April 30. Unscheduled exams may be picked up at the Registrar's office between 8:30-9:00 AM; 1:00-1:30 PM; 6:00-6:30 PM on unscheduled exam days. Saturdays, April 20 & 27, unscheduled exams will be available 1:00-1:30 PM ONLY. On Sunday April 28 unscheduled will be available at 11:00am-11:30am.
