### **Who should attend this event?**

### **Who are the panelists for this event?**

Panelists will be experts in victims' rights and services from across the United States, including victims' rights attorneys who are at the forefront protecting survivor voices in our justice systems; technology experts who have been fighting to bridge the digital divide and privacy experts who understand the intersection of law and technology. These panelists have identified rights in jeopardy during this pandemic and are responding rapidly to keep rights meaningful for

**What panels are included in this event?**

While we cannot cover every critical topic, panels for this conversation will discuss: leveraging technological solutions to aid victims (including meaningful access for all victims) during a crisis; bridging the digital divide; protecting privacy as technology becomes an increasing part of our justice system; unique hurdles human trafficking and immigrant victims face. In addition, on a panel-by-panel basis presenters will address racism and the racial inequities of the system as these intersect with the overall conversation. You will hear a variety of actions being taken by organizations and individuals all across the country to protect rights during the pandemic.
