# Announcement to 3L Students Graduating in May 2021 Diehl Environmental Law Fellows Program Applications due January 13, 2021

### Lewis & Clark Law School Environmental, Natural Resources, & Energy Law Program

Lewis & Clark Law School is the recipient of a bequest from John E. Diehl who was an active environmentalist in Washington. The Diehl bequest supports a fellowship program for Lewis & Clark law school graduates who are planning to work in public interest environmental law. The bequest specified a preference for graduates who are "dedicated to resource conservation, wilderness and wildlife habitat and preservation, or human population stabilization." Recipients will be designated "Diehl Environmental Law Fellows."

Up to three Diehl Fellowships of \$40,000 each will be awarded to students graduating in May of 2021. As part of their application, students will be asked to describe their prospects for qualifying jobs upon graduation with preference given for those with strong leads or offers of post-graduate employment. It is preferable, but not required, that the post-graduate positions be at least two years, with the Diehl funding available in the second year and the employer supporting all costs in the first year. The committee will also consider positions that are just one year. A fourth fellowship is designated for a graduate who has received an Earthrise Law Center fellowship (and will be applied in the second year of the two-year fellowship).

#### **Application Eligibility:**

Applications are available to third year law students currently enrolled at and planning to graduate from Lewis & Clark Law School in May 2021. Applicants must be committed to public interest jobs after graduation in resource conservation, wilderness and wildlife habitat and preservation, or human population stabilization. Qualifying employers include non-government organizations, non-profit organizations, and private firms that focus on public interest environmental work similar to non-profit organizations (e.g., citizen suits). The post-graduate employment must be full time of 35 or more hours per week. Employment with more than one qualifying employer may also count if the total hours worked is at least 35 hours per week.

Students must also be in good academic standing. Grades may be a factor in making final decisions.

Preference will be given to applicants who have already secured a qualifying post-graduate position or who have strong indication they will secure qualifying employment at one or more organizations. In all cases, successful recipients must begin their employment no later than March 15 of the year following their graduation to remain eligible for the fellowship.

The Fellowship funding will be provided upon proof of qualifying employment (letter from employer) and will be made in installments over a 12-month period. The funding can be provided either directly to the employer or to the individual fellow (in the latter case, note that the fellow will be responsible for payment of any taxes).

The Application should include the following information:

- Completed application form (\*include the name of a LC law faculty member who can speak most knowledgably about your interest in public interest environmental law) (application form is attached to these materials). A member of the selection committee will reach out to the faculty member directly.
- Resume
- No more than a 500 word essay detailing your professional commitment to the field of public interest environmental law in the areas of resource conservation, wilderness and wildlife habitat and preservation, or human population stabilization and how receiving a Diehl Fellowship will assist you.
- Unofficial transcript from Lewis & Clark Law School
- List of courses you are planning to take spring semester 2021
- Description of potential or secured qualifying jobs upon graduation
- A letter of recommendation discussing your potential as a future public interest environmental lawyer emailed directly from the recommender to <u>aburchett@lclark.edu</u> (this should be different than the faculty member you identify \*above and can be from a professional or other experience or can be from another faculty member)
