**Costs and Financial Aid**

Summer 2022 tuition is \$1,982.00 per credit hour. Law students and auditors will be charged by the credit hour at the summer tuition rate.

***Visiting law students should apply for financial aid through their home institutions. No financial aid is available for auditors.***

Auditing Attorneys and others interested in summer courses may audit a course if there is space available and the instructor consents. A Bachelor's degree is required to audit. Auditors who wish to receive a certificate of course completion must pass the final exam. Those auditors who do not take the final exam do not receive a certificate. They are deemed "non-certificate" auditors and pay less tuition for the course. CLE credit may be available for attorneys who audit a course. In no case will a transcript be issued for auditors.
