



Douglas K.Newell

Professor of Law



Contracts, Commercial Law, Contract Theory Seminar, Sports Law. B.A., Pomona College, 1962: J.D., Harvard University Law School, 1965. Member, Phi Beta Kappa; State Bar of California. Professor Newell served as clerk to the Honorable William Byrne, U.S. District Court, in 1965-66. He was in private practice in Los Angeles and Glendale from 1966 to 1971, representing many large and small corporations, including banks and surety companies, and specializing in business and commercial law and civil litigation. Newell joined the Law School faculty in 1971. He has taken an active role in school administration. chairing at various times the Admissions, Budget, Building, and Promotion and Tenure Committees. In 1980, he served as faculty representative on a Trustee Task Force to consider the future of the Law School. He also designed and coordinated the visit of Professor Harry Jones as the first Distinguished Higgins Visiting Lecturer, a program funded by the Lorene Sails Higgins Charitable Trust. Currently, he is revising and updating his course materials on sports law.





Professor Douglas K. Newell

Professor **Douglas K. Newell's** book, Security Interests in Personal Property, will be published by Butterworth's this autumn. The book, intended mainly for use as a casebook, developed from Newell's "dissatisfaction with available casebooks." Despite its instructional bent, the book "includes substantial introductory and summary text which might be useful for a practicing lawyer who does not have significant experience with Article 9 problems," Newell says

In the spring the Class of '77 voted Newell Most Valued Professor at their tenth anniversary reunion.
