## Creating a Legacy for Animals

Lewis & Clark Law School **Professor Joyce Tischler** helped found and build the field of animal law starting in the 1970s, and has been a trailblazer ever since. She is affectionately known as the "Mother of Animal Law." Having spent over 40 years practicing animal law, Joyce joined the Center for Animal Law Studies in 2019 and says that "now, my greatest legacy is teaching students to carry on the work that I started." Humans inflict so much suffering on animals, because they are vulnerable and their interests are ignored in legal systems around the world. Donkeys are being skinned, farmed animals are being mutilated on factory farms, wildlife is being poached and their habitats decimated.
