Background

Sid Lezak was one of the longest serving US Attorneys in the history of the United States, the father of alternative dispute resolution in Oregon, an activist, a community servant, and a mentor to many Oregonians. These summer awards are designed to honor his legacy by encouraging law students to serve the Oregon community and by providing mentorship and guidance to these students. Through the Lezak Social Justice Fellowship Awards, the insight, guidance, and encouragement that Sid provided to so many of Oregon's greatest citizens will pass to a new generation.

Awards

Awards of up to \$5,000 will be awarded to Lewis & Clark Law students who will be returning to Lewis & Clark in the fall. Recipients may augment Summer Awards and salaries from other sources with Lezak Social Justice Fellowship Awards; however, students may not receive both a PILP Award and a Lezak Award in the same year. The Lezak Social Justice Fellowship Committee will select recipients from applications received following interviews with finalists. **Interviews will take place on Friday, April 12, 2024, and you must be present for your interview to be eligible for an award.**

Mentors

The Lezak Social Justice Fellowship Committee will match recipients with mentors from the Oregon legal community.

Recipient Obligations

Recipients are required to complete at least 350 hours of work with their host during the summer and are required to meet individually with their mentor(s) and participate in group mentoring events during the summer in Portland.

Hosts and Work

Hosts must be non-profit organizations, government offices, or tribal entities. Work must significantly utilize the student's skills and knowledge gained as a law student; however, the work need not directly connect to legal representation. Work must be completed during the summer.

Payment and Taxes

Summer Awards may be taxable income and will be paid in a single lump sum to recipients. Lewis & Clark must report payment via IRS Form 1099-MISC. There will be no withholding, and recipients will be responsible for saving funds to pay state and federal income tax if any.

In her honor, one of the Lezak Fellowships will be awarded to a student whose summer legal work demonstrates a connection to mental health access, awareness, or support.
