


Class Schedule

There are three ways to view your class schedule: **Planning Overview** for a view your most recent semester, **Plan & Schedule** for a detailed view of your class schedule, and **Timeline** for an overview of your classes for the current semester as well as previous and future semesters.

To access your class schedule:
