


My Progress

My Progress is a degree completion planning tool available for students in the JD program. It tracks the student's overall credit amounts, cumulative GPA, and course requirements.

You can access My Progress two ways:


At a Glance

Where you can view overall progress towards degree completion

- Overall GPA – must be a minimum 2.0 to graduate
- Anticipated Completion Date – let the Registrar’s Office know if your anticipated graduation month and year don’t match your plans
- Progress Bar
 - Overall credits needed to graduate
 - The credits in dark green represent completed credits
 - The credits in light green represent in-progress credits – those courses you’re taking in the current semester
 - The credits in tan represent the credits you have planned for future semesters



Ignore the View a New Program and Load Sample Course Plan buttons – those are tools used by the College of Arts & Sciences and are not relevant to Law students.



Requirements

Where you can view each of your degree requirements and the courses you've taken, registered for, and planned that apply to the requirement.

- A requirement or sub-requirement will not show as completed until all of the required courses/credits are complete with a final grade.
- If the requirement or sub-requirement is not yet completed, you'll see how many credits you've completed towards the requirement and whether your planned courses will complete the requirement.
