- a. Presentation

- a. Student Accounts changes –
 - i. Planning to move to 100% electronic billing.
 - b. Student Financial Services –
 - i. Pending bill would eliminate the LFLP and move to the other loan program so the department is going to be changing to new loan program.
 - ii. There aren't any significant changes but it there will be some administrative differences.
 - c. Looking for suggestions on how to communicate changes to law students –
 - i. Sending e-mails, letters/postcard, use of website
 - ii. Daily announcements including critical points, keeping it short and sweet.
 - iii. Perhaps links to Webadvisors
 - 1. Maybe a message on the grade page.
 - iv. Facebook fanpage
 - v. Speaker coming to law school.
 - vi. Set up an info table in the LRC.
 - vii. Orientation to reach incoming students or in new student packet (one of the two that goes out over the summer).
- 5) Discussion: "Green Fee" – Tara and Laura, SEED undergrad environmental group.**
- a. Currently 30% of the energy powering all three campuses in wind all paid for by the undergrad fee.
 - b. Currently \$20 opt out green fee paid by 95% of undergrad students, to go to 100% wind energy would cost \$85 per undergrad.
 - c. If the law school signs on then fee would be \$20 optional student fee (it would opt-in for law students). The fee for grads would be \$15 and the undergrads would cover the rest.

 - i. Most students teach criminal law in the first year b/c it's a statutory class.
 - ii. Jason wants to ask the committee to reopen the issue of whether to teach this in the first year. Hoping for SBA support.

- iii. Concerns as to how to implement this for evening students.
- iv. Crim Pro is substantively better for first years to know who are going to be working in criminal law the first year.
- v. Does the first year legal elements teach statutory analysis?
- vi. **VOTE: Approved solely to re-open the issue.**
