The Center for Animal Law Studies at Lewis & Clark (CALs), in collaboration with the Animal Legal Defense Fund (ALDF), is excited to announce that registration is about to open for the 2011 National Animal Law Competitions (NALC). Space fills quickly, so register early to ensure your spot!

ALDF will once again provide travel grants to active SALDF chapters. Each chapter is eligible to apply for a maximum grant amount of \$400, which can be used to offset the expenses of registration and travel. Funds awarded must be divided between members, as there is only one grant available per chapter. Funds are limited and will be awarded on a first-come, first-served basis. To request a travel grant, the chapter president should send an email to Nicole Pallotta at npallotta@aldf.org with the following information:

- Chapter name/ law school
- Amount requested (up to \$400)
- Contact person
- Names of participants
- Email address
- How do you plan to use the grant (e.g. airfare, registration, hotel, etc.)?

** Competitors may register for two out of the three competitions - No one may compete in all three.*

APPELLATE MOOT COURT COMPETITION: Fee of \$425 per team (Open to 2Ls-4Ls)

An Appellate Moot Court team is composed of two students who have completed at least one year of legal study at an accredited law school in the United States. Space is limited to the first twenty teams that register and pay the registration fee. No more than two teams from the same law school may participate.

CLOSING ARGUMENT COMPETITION: Fee of \$225 per participant (Open to 2Ls-4Ls)

The Closing Argument Competition is open to students who have completed at least one year of legal study at an accredited law school in the United States. Space is limited to the first sixteen students who register and pay the registration fee. No more than two students from the same law school may participate.

LEGISLATIVE DRAFTING & LOBBYING COMPETITION: Fee of \$225 per participant (Open to 1Ls-4Ls)

This competition is open to *all* law students currently studying at an accredited law school in the United States. Space is limited to the first twenty students who register and pay the registration fee. No more than two students from the same law school may participate.
